DEED OF GIFT TO THE ROYAL VANCOUVER YACHT CLUB OF A TROPHY TO BE KNOWN AS "EDD CHISHOLM MEMORIAL TROPHY," DONATED BY MRS EDD CHISHOLM.

1. Know all men that I, Mrs Edd Chisholm, of the City of Vancouver in the Province of British Columbia, hereby give this Trophy to be known by the title given above, to the ROYAL VANCOUVER YACHT CLUB.
2. The Trophy shall be held, competed for and awarded on the following conditions:
 - a) To the first place yacht in the International Dragon Class of the Olympic Regatta.
 - b) In the event that the International Dragon Class is not eligible for the Olympic Games, then for such other Olympic class at the discretion of the Executive Committee of the ROYAL VANCOUVER YACHT CLUB.
 - c) In the event that the ROYAL VANCOUVER YACHT CLUB no longer conducts the Olympic Regatta, the Executive Committee of the Club may offer the Trophy for competition from time to time as they shall consider in the best interests of the Club or of the sport of yachting generally and the races or competition shall be sailed or held in such classes and conditions as may be designated by the ROYAL VANCOUVER YACHT CLUB.
3. Title to the Trophy shall always be vested in the ROYAL VANCOUVER YACHT CLUB. The Trophy shall not become the property of any winner or holder, but any winner may have temporary possession as the Executive Committee shall, at its discretion, decide from year to year.
4. Winners shall be entitled to have their names, vessels names, and year, neatly and suitably engraved on the mount of, or upon the trophy itself as the Executive Committee shall decide.
